During the room search conducted by the committee, comprised of three female faculty members, along with the roommate and two students (Gayatri-35123210001, Aseel Ibrahim-11023210193) who raised similar complaints, stolen items were discovered in the cupboard of student Tanya, Registration Number: 35123210038, MBA 1st Year.

Upon questioning, Tanya admitted to the theft and returned the items to the rightful owners. Additionally, she provided a written apology for her actions.

The entire incident has been communicated to Tanya's parents.

The committee conducted a thorough discussion regarding Tanya's actions and recommended her immediate suspension for both hostel accommodations and academic activities until further notice.
