### **Terms of Reference of the Board of Studies (BoS):**

The Board of Studies (BoS) of the respective Department shall perform the following functions:

- a) To examine, discuss, and finalize the detailed syllabi of various courses/programmes prepared by the concerned faculty members of the Department.
- b) To consider and incorporate the observations, suggestions, and recommendations made during the deliberations of the Board and finalize the course contents accordingly.
- c) To recommend the finalized syllabi and curriculum, along with the recommendations of the Board of Studies, to the Academic Council for approval and subsequent implementation/publication.
- d) To review, revise, and update the curriculum, syllabi, and course structure from time to time and submit the same to the Academic Council for approval.
- e) To recommend the introduction, modification, or discontinuation of courses/programmes in accordance with academic and industry requirements.
- f) To advise on matters relating to teaching, research, innovation, training, internships, and other academic activities of the Department.
- g) To ensure compliance with the guidelines of regulatory bodies, statutory authorities, and the University in curriculum design and academic delivery.
- h) To perform such other powers and functions as may be assigned under the Statutes, Ordinances, Regulations, Rules, and policies of the University from time to time.
